Dear Church Family: In the course of renewing our church's PA
tax-exempt number, we discovered we need a "Dissolution Clause"
in our Constitution. We do not have one, so we will have a special
business meeting Sunday, August 21 to vote on the following:

"In the event of the dissolution of this corporation, all assets will be
distributed only to other corporations holding to the doctrinal position
of Venture Church Network, and which also qualify for exempt status
for tax purpose under the then current provisions of the Internal
Revenue Code of the United States. In the distribution of asses,
primary consideration will be given to Venture Church Network,
Mid-Atlantic Region, PO Box 345, Clayton, NJ 08312. Next in line
would be a local ministry of common conviction."
